Case Synopsis:

DECEASED, [REDACTED] IS A 3 YEAR OLD WHITE MALE THAT WAS REPORTED MISSING BY HIS FATHER AT 0607 HRS, ON TUESDAY, OCTOBER 13, 2015. 911 WAS CALLED AND A LARGE AREA SEARCH WAS CONDUCTED BY MULTIPLE POLICE AGENCIES ALONG WITH THE WESTMONT FIRE COMPANY. HIS BODY WAS LATER FOUND BY A POLICE DOG IN A CREEK IN THE COOPER RIVER PARK LOCATED NEAR SOUTH PARK DRIVE AND SAGINAW AVE, IN HADDON TOWNSHIP. CAMDEN COUNTY PROSECUTORS OFFICE RESPONDED TO THE SCENE AND MADE NOTIFICATION TO THE M.E.O. FOR THE INVESTIGATION.

THE SCENE WAS DEEP IN A WOODED AREA AT THE ABOVE MENTIONED LOCATION. THE DECEASED WAS OBSERVED FACE DOWN IN A SHALLOW CREEK DRAPED OVER A ROCK. HIS HEAD WAS FACING TOWARDS THE NEAR BANK AND THE HAIR ON THE RIGHT SIDE OF HIS HEAD WAS DRY. HIS HEAD AND TORSO WERE NOT UNDER WATER. HIS ARMS AND LOWER LEGS WERE UNDER WATER. HE WAS CLOTHED IN PAJAMAS AND HIS DIAPER WAS PULLED DOWN EXPOSING HIS BUTTOCKS. HIS SOCKS WERE ON AND DID NOT APPEAR TO BE SOILED. SMALL AREAS OF BRUISING WERE NOTED ON HIS LOWER BACK AND THE BACK OF THE LEFT ARM, ABOVE HIS ELBOW.
